### **WHAT IS COVERED BY THIS LIMITED WARRANTY:**

Larsen Innovations LLC warrants the original purchaser and not any other purchaser, or subsequent owner, that its ACCURA Precision Cantilever Rollers and Truck Assemblies are free from defects in material or workmanship for a period of five (5) years from date of purchase.

### **WHAT IS NOT COVERED BY THIS LIMITED WARRANTY:**

Damage or failure from improper or abnormal use, improper gate design, accident, alteration, neglect, abuse, air pollutants, improper service or installation, or damage caused by flood, fire or act of God is not covered by this limited warranty. Damage or failure due to reaction loads in excess of 4000 pounds for Precision External Cantilever Rollers or 2000 pounds for Internal Truck Assemblies is not covered by this warranty.
